My study examined the extent to which PTSD symptoms and resiliency predicted veteran's mental and physical quality of life; specifically, whether resiliency moderates the relationship between PTSD symptoms and quality of life, in a sample of military veterans. Data was collected from 93 individuals who volunteered to participate in a biofeedback –assisted breathing training study through the Palo Alto Veteran's Affairs office, funded by Stanford University. Data was collected using validated self-report assessment tools as well as structured clinical interviews, including the SCID and the CAPS. Measures used for this study were the CAPS, CD-RISC and the SF-36.

This study examined the relationship between spirituality and a teenager's experience of her pregnancy, using a Theory of Reasoned Action (TRA) framework. Individual semi-structured interviews were conducted with eight pregnant teenagers. Data was coded and analyzed using a Consensual Qualitative Review (CQR) method.
